



## ORDINANCE NO. 702

First Reading (By Title Only): June 25, 2018  
Second Reading: July 9, 2018

An Ordinance to Amend the Budget Ordinance for Fiscal Year Beginning July 1, 2018, and Ending June 30, 2019, and Authorizing the Supplemental Appropriation of Funds.

WHEREAS, Fairfield County Council adopted and enacted Ordinance No. 696, Fiscal Year 2018-2019 Budget; and

WHEREAS, Fairfield County Council desires to make a supplemental appropriation and to amend the above referenced Ordinance for certain purposes, including:

1. An Appropriation of Funds from the enactment of new fees relating to Dogs Running At Large as properly enacted by Fairfield County Council;
2. An Appropriation of Funds from the enactment of new fees relating to the use of the County Wood Chipping Facility as utilized by commercial users; and
3. An Appropriation of Funds from the Fairfield County Fee Schedule previously approved by Fairfield County Council which is attached and incorporated herein.

NOW, IT IS HEREBY ORDAINED by Fairfield County Council as follows:

1. The total revenues for the operating budget for the current fiscal year, beginning July 1, 2017, and ending June 30, 2018 ("2017-18 Fiscal Year"), are \$38,757,185; \$31,493,328 general fund and \$7,263,857 all other funds. For 2017-18 fiscal year, the total expenditures for the operating budget are \$38,757,185; \$31,493,328 general fund and \$7,263,857 all other funds. The total revenues for the operating budget as amended for the upcoming fiscal year, beginning July 1, 2018, and ending June 30, 2019 ("2018-19 Fiscal Year"), are \$40,455,085; \$32,816,306 general fund and \$7,638,779 all other funds. For 2018-19 Fiscal Year, the total expenditures for the operating budget as amended are \$40,455,085; \$32,816,306 general fund and \$7,638,779 all other funds. The percentage change between the 2017-18 fiscal year and the 2018-19 fiscal year operating budgets for revenues is an increase of 4.38% and for expenditures is an increase of 4.38%.


2. The current operational millage rate for the 2017-18 fiscal year is 181.8; 160.0 general fund and 21.8 all other funds. The estimated operational millage rate for the 2018-19 fiscal year as necessary to provide for the 2018-19 fiscal year is 181.8; 160.0 general fund and 21.8 all other funds.

3. The attached fee schedule, included as Exhibit A to this Ordinance, is hereby incorporated by reference into the Amended Budget Ordinance for Fiscal Year Beginning July 1, 2018, and Ending June 30, 2019.


4. That the fees and funds as shown on the attached Exhibit are hereby appropriated as part of the Fairfield County Budget for the Fiscal Year beginning July 1, 2018 and Ending June 30, 2019, and incorporated therein for the purposes stated, and except as amended the Budget Ordinance is reaffirmed.


Moreover, pursuant to Section 6-1-330 of the S.C. Code of Laws, as amended, Fairfield County proposes to adopt a service or user fee for: (1) debris disposal at Fairfield County waste collection sites for the benefit of Fairfield County residents, and (2) Animal Control – Dog Running at Large Redemption fee. These services were previously funded by property tax revenue.


