



## ORDINANCE NO. 779

### **An Ordinance To Make Supplemental Appropriations From The Fund Balance To Purchase Compactor Receivers For The Mack And Ridgeway Recycling Sites.**

WHEREAS, Fairfield County Council adopted and enacted Ordinance No. 767, Fiscal Year 2021-2022 Budget; and

WHEREAS, Fairfield County Council desires to authorize funding for an employment position previously suspended from funds in the personnel contingency fund.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL:

**Section 1.** Section 1 of Ordinance 767, under "Fairfield County Revenues", is amended to appropriate an additional amount of \$37,196 from the Fund Balance. Line 4710, "Appropriation from Fund Balance", is increased from \$1,413,856 to \$1,451,052; the subtotal under "Fairfield County Revenues" is increased from \$5,056,532 to \$5,093,728; the "Total General Fund Revenue" is increased from \$33,757,551 to \$33,794,747; and "Total All Revenues" is increased from \$42,619,792 to \$42,656,988.

**Section 2.** Section 1 of Ordinance 767, under "Appropriations", is amended to increase the appropriation to Line 100-017, "Solid Waste", by \$37,196. Line 100-017, "Solid Waste" is increased from \$2,314,521 to \$2,351,717; the "Total General Fund" is increased from \$33,757,551 to \$33,794,747; and "Total Appropriations/All Funds" is increased from \$42,619,792 to \$42,656,988.

**Section 3.** From monies appropriated in Line 100-017 for "Solid Waste" in Ordinance 767, \$37,196 shall be expended to purchase three compactor receiver boxes, to be placed at the Mack recycle site and the Ridgeway recycle site, respectively.


**Section 4.** The Supplemental Appropriations provided for by this ordinance are hereby appropriated as part of the Fairfield County Budget for the Fiscal Year beginning July 1, 2021, and Ending June 30, 2022, and incorporated therein for the purposes stated, and except as amended the Budget Ordinance No. 767 is reaffirmed.

**Section 5.** The provisions of the Ordinance are separable. If any part of this Ordinance is, for any reason, unenforceable then the validity of the remainder of this Ordinance is unaffected.

**Section 6.** *General Repealer.* Any ordinance, resolution, or other order of County Council, the terms of which are in conflict with this Ordinance, is, only to the extent of that conflict, repealed.

**Section 7.** *Effectiveness.* This Ordinance is effective after third reading and a public hearing.


